

How much are the subsidies for energy storage projects in the Netherlands

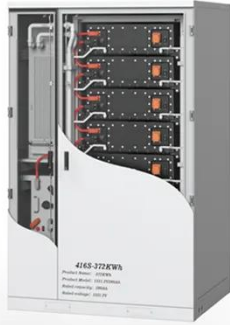


Overview

The Dutch government has earmarked €100 million (\$106.7 million) of subsidies for the deployment of battery storage alongside PV projects. Minister for climate and energy policy and D66 party leader Rob Jetten announced. These two subsidy schemes, now under legislative review, include PLN 4 billion (MF) and, respectively, €200 million (RRP) budgets to aid businesses investing in lithium-ion technology energy storage and grid infrastructure, strengthening the country's energy system.
