## Overview

---

The European Commission has approved, under EU State aid rules a €17.7 billion Italian scheme to support the construction and operation of a centralised electricity storage system. The measure contributes to the achievement of the objectives of the European Green Deal and 'Fit for 55' package, by. On Decem, the European Commission greenlit a substantial €17.7 billion scheme. Just under 4GWh is completed and/or operational, with a further 2GWh+ under construction. The demand for energy storage in Italy has been clear over the last half a decade, with solar and wind generation. "The expectation is that by 2030 almost 20 billion euros will be invested in accumulation technologies in Italy, and we want to play a leading role in this transformation," says Julian Nebreda, CEO of Fluence-multinational active in 50 countries, 15 of which in Europe.

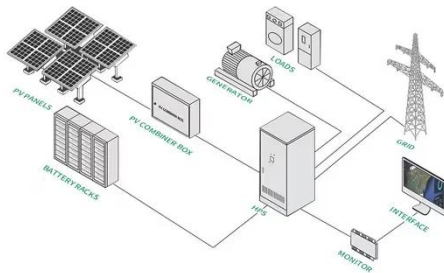

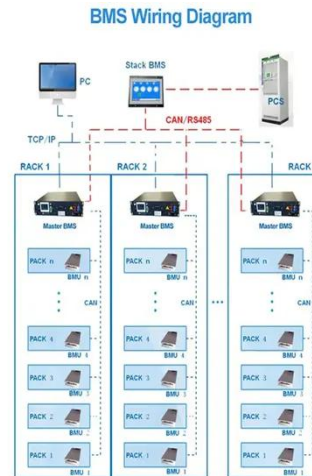
