

# Luxembourg city electric vehicle incentives



## Overview

---

Luxembourg announced its extension of the electric car subsidy program by two years. Battery-electric passenger cars and vans are eligible for a grant of €8,000, covering up to 50% of the purchase price and with an electric energy consumption not exceeding 180Wh/km. Who is concerned: any owner, holder or keeper, whether resident or non-resident, of a vehicle registered in Luxembourg. Deadlines: the deadlines vary according to the situation.
