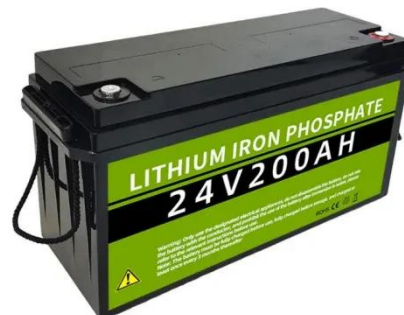

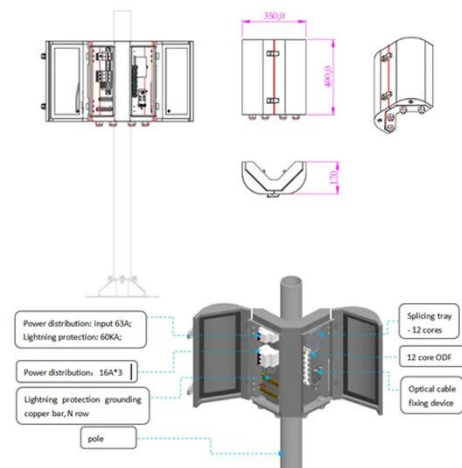

Minimum corporate tax applies to electricity production at 0.25%, instead of 0.5% for other activities (minimum tax is calculated on the annual turnover and applies mainly in the case of tax losses).

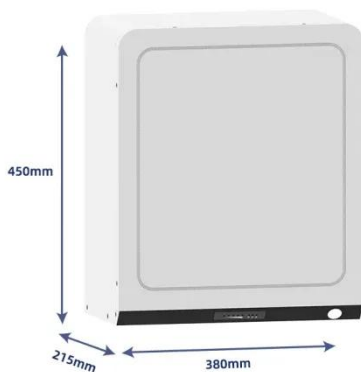
