Overview

On April 1, the U. Department of Commerce (Commerce) announced its final affirmative determinations in the antidumping duty (AD) and countervailing duty (CVD) investigations of crystalline photovoltaic cells whether or not assembled into modules (solar cells) from China. On April 1, the U. Trump's Energy Dominance agenda, the Department of the Interior is ending preferential treatment for unreliable, subsidy-dependent wind and solar energy. The move follows the signing of Executive Order 14315, Ending Market Distorting Subsidies for. Subsidized solar farms have made it more difficult for farmers to access farmland by making it more expensive and less available. 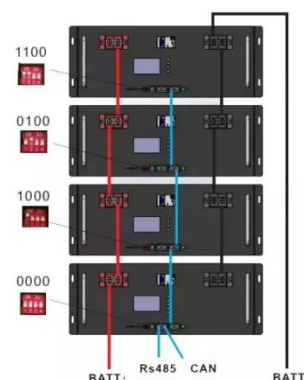
