

# Rural photovoltaic panel leasing compensation policy



## Overview

---

Lease Duration: Solar leases are long-term, typically ranging from 20 to 50 years, with possible extensions in 5 or 10-year increments. Consider how this duration may impact future land use plans. Some leases may pay a fixed rate based on the potential megawatts of power that the project could generate or even pay a royalty payment of some percentage of the power actually produced while many leases pay a fixed amount per acre per year. As such, landowners and ag operators are counseled to approach commercial solar energy leases with caution and should avail themselves generating in excess of five megawatts (MW) of electricity.
