Overview

In fact, in 2020, 580 GWh or nearly 100 % of electricity was produced from oil and gas, and just 1 GWh from renewable sources.

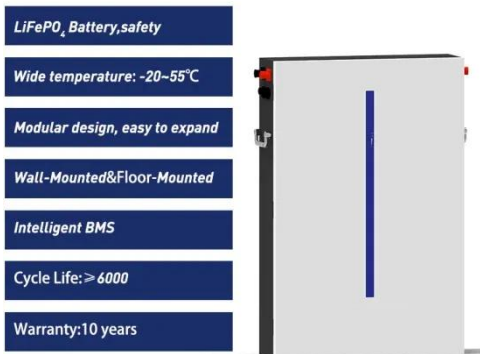
