Overview

Federal and state programs reward microgrids that reduce emissions, support resilience, provide thermal efficiency, or improve grid stability. In fall 2019, the National Association of Regulatory Utility Commissioners (NARUC) and the National Association of State Energy Officials (NASEO) initiated a joint Microgrids State Working Group (MSWG), funded by the U. Department of Energy (DOE) Office of Electricity (OE). The MSWG aimed to bring State Grid International Development Co. (SGID), set up in June 2008 in Beijing as a wholly-owned subsidiary of State Grid Corporation of China (State Grid), is responsible for State Grid's overseas investment and operations of energy assets. It is the largest utility company in the world. As of March 2024, State Grid is the world's third largest company overall by revenue, behind Walmart and Amazon, and.
