Corporate tax is levied at a rate of 10% on most activities, although there are benefits that can reduce it to 2%. Andorra is a true tax haven within Europe, offering very low tax rates for both corporations and individuals. For residents, income tax ranges from 0% to 10%, well below that of most. However, it won't exactly be possible since January 1st, 2023: according to the new tax reform, if a company makes a profit, its minimum effective rate for the corporate tax will be 3%. Companies must file a tax return within a month following the six-month period after the end of the accounting.
