Senate preserves battery storage tax credits through 2033 while phasing out EV incentives and renewable energy tax breaks. New bill maintains grid storage incentives but cuts \$7,500 EV credit within 180 days, threatening automakers' plans. Due to increases in demand for electric vehicles (EVs), renewable energies, and a wide range of consumer goods, the demand for energy storage batteries has increased considerably from 2000 through 2024. Energy storage batteries are manufactured devices that accept, store, and discharge electrical. The One Big Beautiful Bill Act (OBBB) is set to dramatically reshape how grid scale and residential energy storage systems are treated under federal tax law. The new budget package revises critical incentives laid out by the IRA, focusing particularly on foreign sourcing restrictions, new domestic.
